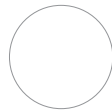

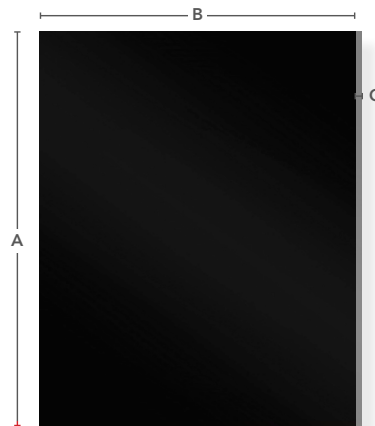

DESCRIPTION

Stein splashbacks are intended for use on the walls of kitchen and bathroom areas, such as behind sinks and vanities, or cooktops. Splashbacks are made using 5mm Toughened Safety Glass (AS/NZS 2208).

Stein splashbacks are available in a range of sizes to suit different configurations, from 600x200mm up to 750x900mm. There are also colour options available, including diamante white, blush red, silver, black, duck egg blue and willow. Sample swatches are available for purchase.

CONTRIBUTIONS TO COMPLIANCE

B1.3.1, B1.3.2, B2.3.1 (c)(i): Stein splashbacks are made from 5mm Toughened Safety Glass. The toughening process ensures that splashbacks will maintain stability and throughout the use of the building when correctly installed. Splashbacks have a warranted durability of 5 years when maintenance standards are adhered to.

C3: When installed within 200mm of a gas burner or open cooktop, splashbacks are installed with specific wallboard to minimize heat transfer. Non-combustible backer board is specified in the installation instructions.

G3.3.2: Splashbacks are made from glass that is impervious, easily cleaned, and free of hazardous substances. Refer to Stein Aftercare document for additional information.

SCOPE OF USE

Stein Splashbacks are designed for use in the following environments:

- Residential bathrooms and kitchens.
- Used as a wall mounted splashback on a primed or undercoated wallboard, concrete, or brick surface. Ensure paint is fully cured before installation.
- Not intended to provide structural bracing to the building.

CONDITIONS OF USE

- Stein splashbacks are intended for use on hard wall surfaces in kitchen and bathroom areas. Soft coverings should be placed on hard surfaces to protect against glass damage during storage and installation.
- Glass splashbacks cannot be cut or reworked in any way as they constructed from toughened glass. Attempts to rework the glass will void warranty.
- There may be electrical wires or gas pipes near the splashback. It is important to determine the location of these prior to drilling the wall cavity.
- Must be installed in accordance with Stein splashback installation manual.
- Cleaning products including bleaches, solvents, alcohol, citrus based chemicals, bath oils, and/or any abrasive cleaner should not be used. Full list is outlined in aftercare document.
